■STEP ONE:

You will need to sign on the questionnaire that you have read this and understood.

■STEP TWO:

First contact – please send an email or fax to Migration Advisor be briefly explaining your question.

■STEP THREE:

Reply – **Migration Advisor Pty. Ltd.** will contact you with a brief message by email which will include the following:

- A questionnaire
- Available times for a consultation (Note the consultation will be from 15-60 minutes visa telephone or SKYPE. Time over 60 minutes will require an extra charge.
- Payment details

■STEP FOUR:

Clients wishing to have a consultation need to return the questionnaire and proof of payment. Clients will also need to nominate 3 suitable times. (NOTE : the time is Australian time- which is one hour ahead of Japan if calling from Japan)

■STEP FIVE:

Migration Advisor will confirm time.

■STEP SIX:

At the set time, contact Migration Advisor via the communication method you have nominated.

Migration Advisor will provide a consultation addressing the information provided by you on the questionnaire and through the consultation. This consultation will be provided at a cost of AUD \$55 (includes \$5 GST). The consultation may take up to 60 minutes only. (this is a special price for Ryugaku Journal Clients only and is only valid for the first consultation)

At this stage Migration Advisor Pty. Ltd. will also provide information regarding fees and how to proceed should you wish to make any visa application.

■STEP SEVEN:

If you decide to proceed with Migration Advisor services to assist you with your application then you will need to contact Migration Advisor and a more detailed consultation may be necessary. This consultation and all further work on your case will be included in the fees recommended to you in Step Six.
